EFFECTIVE JANUARY 1, 2011**


WHEREAS, it is in the best interest of judicial efficiency and utilization of the circuit judges to adjust the circuit assignments within the county to a divisional assignment system, it is, therefore

ORDERED and ADJUDGED that the following Santa Rosa County circuit division assignments will be in effect January 1, 2011:
